FOR 2021- 2022 SCHOOL YEAR

Upon a motion by Mrs. Rosales, seconded by Mr. Centamore, the Board of Education unanimously approved the following Resolution:

RESOVLED, that based on the budget approved by the voters on May 18, 2021 below is the tax levy for the 2021-2022 school year:
